- 30-35 checks were deposited
- Slight net loss due, partially due to low entries at Zone Champs
- Q (Larry Rice) Current balance?

- A \$56k
- Note (Larry Rice, Laura) Zone Challenge expenses and Officials shirts should not come out of Zone Champs, but should come out of / be categorized under General fund
- Note (Larry Rice) Encouraged Zone to commit to use of touchpads when hiring FastLaneTek or other for future Zone Champs

## Sanctions - Kayla

- Reminder that hosts of dual meets are responsible for comparing meet sheets and opening entries at the same time

## Officials - Katherine and Sylvain

- (Kathy) Goal for next season more officials from each club
  - Some clubs have only 1 or 2 officials
- (Sylvain) several small clubs have no officials, some large clubs provide a disproportionate number of officials at meets. Officials are encouraged to upgrading their official certification
- Q (Jose) Are host clubs responsible for waiving entry fees? One of the best ways to motivate new parents become certified
  - A host clubs are allowed to choose if they waive entry fees or not
  - A (Kathy) most clubs do
  - A (Sylvain) for many clubs, benefits of officiating (e.g. double volunteer hours, not having to time) are enough
  - A (group) Most hosts will allow officials' athletes to be entered in meets after entry cap has been met / problem if timelines get out of control
  - Suggestion (Laura, Kathy, Sylvain) Officials Chairs and Zone can use opportunities at CBA meets to share information and promote officiating
  - Suggestion (Laura) Some clubs offer thank you gifts to working officials instead of waiving entry fees. Host clubs are responsible for budgeting these expenses
- Q (Ben) Has Zone 1 North been enforcing officials minimums (1 official per 25 athletes entered)
  - A Yes & No (not as much during pandemic)
  - Note Zone 1 North rule has been to require clubs to assign certified coaches to officiate if meet is short on officials from other clubs
- Suggestion (Laura) Check officials check-in lists from previous CBA meets to determine where Zone is falling short
  - Note (Sylvain) when short-staffed officials do not get breaks. Goal may be to have at least one official per every 3 lanes
- Positive note (Sylvain) official availability is improving from 6 months ago
