## LIVERMORE AQUACOWBOYS PACIFIC SWIMMING SHORT COURSE TIME TRIAL DECEMBER 12, 2020



SANCTION: Held under USA/Pacific Swimming Sanction No. 20-085

**USE OF AUDIO AND VISUAL:** Photography and video recording from behind the blocks or starting areas is prohibited unless prior permission is granted by the Meet Referee. Use of any audio or visual recording devices, including but not limited to film and digital cameras, cell phones and tablets, and Google Glass is not permitted in changing areas, rest rooms or locker rooms. Violation of this recording prohibition may result in ejection from the swimming pool facility by the Meet Referee or his/her designee.

LOCATION: Robert Livermore Community Center, 4444 East Ave. Livermore CA 94550

**DIRECTIONS:** 580 Freeway to Vasco Road, South. Right onto East Avenue. Right onto Loyola Avenue. Parking lot on your left. DO NOT PARK ON LOYOLA AVENUE IN FRONT OF APARTMENTS. YOU WILL BE TICKETED BY THE LIVERMORE P.D.

**COURSE:** Outdoor 25 yard pool with up to 8 lanes available for competition (We will be racing in every other lane, with a buffer lane in between each competition lane). An additional 5 lanes will be available for warm-up/cool down throughout the competition. The minimum water depth for the shallow end course, measured in accordance with Article 103.2.3, is 9 feet at the start end and 9 feet at the turn end. In accordance with Article 104.2.2C(4) the competition course has been certified. A copy of the certification is on file with USA Swimming.

**TIME:** Meet will begin at **1pm** Saturday with warm-ups from **12:00-12:45**. A maximum of two (2) athletes shall be permitted per warm-up lane. The athletes shall start from opposite ends of the pool.

## **RULES:**

• Current USA and Pacific Swimming rules and warm-up procedures will govern the meet. A copy of these procedures will be posted at the Clerk-of-Course.

- All applicable adults participating in or associated with this meet, acknowledge that they are subject to the provisions of the USA Swimming Minor Athlete Abuse Prevention Policy ("MAAPP"), and that they understand that compliance with the MAAPP policy is a condition of participation in the conduct of this competition.
- All events are timed finals.
- All events will swim fast to slow.
- Athletes may compete in Maximum 5 events per day.
- All Athletes ages 12 and under should complete competition within four (4) hours.
- If local conditions warrant it the Meet Referee, with the concurrence of the Meet Director, may require a mandatory scratch down. Refunds will be made for any mandatory scratches.
- All Coaches and Officials must wear their USA Swimming membership cards in a visible manner.
- All athletes 18 and older must have completed the Athlete Protection Training to be allowed to compete.
- At the discretion of the Meet Referee, different events and genders may swim combined.
- All Participants will follow the Facility Safety Guidelines which will be emailed to all Participants prior to the meet and which will be announced prior to the meet.

**UNACCOMPANIED ATHLETES:** Any USA Swimming Athlete-Member competing at the meet must be accompanied by a USA Swimming Member-Coach for the purposes of Athlete supervision during warm-up, competition and warm-down. If a Coach-Member of the Athlete's USA Swimming Club does not attend the meet to serve in said supervisory capacity, it is the responsibility of the Athlete or the Athlete's legal guardian to arrange for supervision by a USA Swimming Member-Coach. The Meet Director or Meet Referee may assist the Athlete in making arrangements for such supervision; however, it is recommended that such arrangements be made in advance of the meet by the Athlete's USA Swimming Club Member-Coach.

**RACING STARTS:** Athletes must be certified by a USA Swimming member-coach as being proficient in performing a racing start or must start the race in the water. It is the responsibility of the Athlete or the Athlete's legal guardian to ensure compliance with this requirement.

## **RESTRICTIONS:**

- Smoking and the use of other tobacco products is prohibited on the pool deck, in the locker rooms, in spectator seating, on standing areas and in all areas used by Athletes, during the meet and during warm-up periods.
- Sale and use of alcoholic beverages is prohibited in all areas of the meet venue.
- No glass containers are allowed in the meet venue.
- No propane heater is permitted except for snack bar/meet operations.
- All shelters must be properly secured.
- Deck Changes are prohibited.
- Destructive devices, to include but not limited to, explosive devices and equipment, firearms (open or concealed), blades, knives, mace, stun guns and blunt objects are strictly prohibited in the swimming facility and its surrounding areas. If observed, the Meet Referee or his/her designee may ask that these devices be stored safely away from the public or removed from the facility. Noncompliance may result in the reporting to law enforcement authorities and ejection from the facility. Law enforcement officers (LEO) are exempt per applicable laws.
- Operation of a drone, or any other flying apparatus, is prohibited over the venue (pools, Athlete/Coach areas, Spectator areas and open ceiling locker rooms) any time Athletes, Coaches, Officials and/or Spectators are present.

## **ELIGIBILITY:**

- Athletes must be current members of USA Swimming and enter their name and registration number on the meet entry card
  as they are shown on their Registration Card. If this is not done, it may be difficult to match the Athlete with the registration
  and times database. The meet host will check all Athlete registrations against the SWIMS database and if not found to be
  registered, the Meet Director shall accept the registration at the meet (a \$10 surcharge will be added to the regular
  registration fee). Duplicate registrations will be refunded by mail.
- Meet is open only to qualified athletes registered with **LAC**. Athletes who are unattached but participating with **LAC** are eligible to compete.
- Entries with "NO TIME" will be ACCEPTED
- Disabled Athletes are welcome to attend this meet and should contact the Meet Director or Meet Referee regarding any special accommodations on entry times and seeding per Pacific Swimming policy.
- Athletes 19 years of age and over may compete in the meet if they are attached to LAC.
- The Athlete's age will be the age of the Athlete on the first day of the meet.

**ENTRY FEES:** \$30 per athlete. Entries will be rejected if payment is not sent at time of request. No refunds will be made, except mandatory scratch downs.

**ENTRIES:** All entries will be made by LAC Aquatics Director by December 1, 2020 on request. Entries will be made in such a way that allows all athletes to participate in 5 events and to remain in their bubbles. Entries will be accepted up to the number of athletes that can be accommodated per facility restrictions.

CHECK-IN: The meet shall be pre-seeded. Athletes shall report to the bull-pen area at their scheduled time for each event.

**SCRATCHES:** Any Athletes not reporting for or competing in an individual timed final event that they have entered shall not be penalized.

AWARDS: None.

**ADMISSION:** There will only be admission for listed participants. Parents who are not participants may view the Time Trials through the gate of the Aquatics Center while wearing facemasks.

MISCELLANEOUS: No overnight parking is allowed. Facilities will not be provided after meet hours.

**EVENTS OFFERED:** 50 FR, 50 FL, 50 BK, 50BR, 100 FL, 100 BK, 100 BR, 100 FR, 200 FL, 200 BK, 200 BR, 200 FR, 200 IM, 400 IM, 500 FR, 1650 FR
