✓ In an effort to advance understanding of diversity issues unique to Pacific Swimming, the Pacific Swimming Diversity Committee is asking for the help of its teams in compiling information pertinent to the race and ethnic background of its swimmers. Since as much as 50% of swimmers leave ethnic background questions blank on their USA Swimming Registration forms, Pacific is currently asking that each team submit an analysis of its ethnic make-up so that Pacific will have more accurate information about its members. They ask that each team submit this information by February 28<sup>th</sup>.

## Officials' Report:

- ✓ There will be an Officials' Clinic on Saturday, January 17, at the Carson Polytathlon. All interested and willing parents are invited and encouraged to attend.
- ✓ A brief discussion and debate regarding the new 'no-show' policy (see below) for Pacific Swimming included concerns pertaining to whether or not the new policy is necessary and/or would be an improvement over the existing policy, one which seems already effective for teaching swimmers about competing in the events for which they have checked in and scratching events they do not plan on swimming. Additional concerns pertain to potential issues regarding clerk of course, having swimmers checking in a second time, and enforcement of this new policy throughout the course of a meet. Effective January 1, 2009, the 'second-chance rule' states that

"a swimmer who has checked into a deck-seeded event who fails to swim the event must return to the clerk of course and repeat the check-in process for any subsequent events the swimmer wishes to swim. A swimmer who does this may swim in subsequent events without penalty. Following a no-show, if the swimmer does not recheck in for an event, the swimmer will not be permitted to swim the event. If the swimmer re-checks in for an event but does not swim the event, the swimmer will be barred from the next individual event in which s/he is entered."
