LSC Report:

- ✓ Effective September 1, 2014, increase Athlete and Non-Athlete Annual Registration dues \$8 every 5 years, with the option to reevaluate the need for a second increase prior to the 2020 membership year. This increase goes into effect September 1, 2014 with the 2015 membership year.
- ✓ Effective September 1, 2014, increase Meet Event Entry Fees (e.g., Age Group Entry Fee \$2.75 to \$4.00; JO \$5.50 to \$7.50; FW \$5.50 to \$10.00, etc.)
- ✓ Pacific Swimming is currently investigating the feasibility of development and implementation of a Pacific owned OME (Online Meet Entry) System
- ✓ Athlete applications are now available for the 2014 Western Zone & NACC All-Star Meets. Interested and prospective swimmers are encouraged to apply.
- ✓ Any teams who maintain registration credits with Pacific Swimming will have them refunded prior to September 1, 2014, after which they may establish new credits for the 2014-15 year.
