- ✓ BOD (Jerry & Valerie Rudd / Jim Morefield): Last meeting was July 23, with minutes posted to pacswim.org. Passed a designated fund for excess membership fees collected during the initial years of the fee increase, to be applied to shortfalls in the later years.
