### 5. Announcements & Correspondence:

- Congratulations to Katelyn Crom (LAKE), Madeleine Lewis (LAKE), and Blair Hall (LAKE),** who were selected to the **2017 Pacific Swimming Western Zone All-star Team**. The all-star team will be competing in Roseville, CA, August 8-13.
- USA Swimming Scholastic All-America applications are due online August 15<sup>th</sup>.** For more information visit the Pacific Swimming or USA Swimming web sites.
- Congratulations to Zone 4 graduates Michael Weiss (LAKE/Wisconsin Aquatics), Shelby Koontz (DDST/Indiana University), and Rachel Matsumura (LAKE/Indiana University)** who competed strongly at the **2017 Phillips 66 National Championships** in Indianapolis June 27-July 1. **Michael** competed in 3 events, placing 7<sup>th</sup> in the A-final of the 200m individual medley (1:59.62), and 8<sup>th</sup> in the B-final of the 200m freestyle (1:48.94). **Shelby** competed in 4 events, placing 32<sup>nd</sup> overall in the 100m butterfly (1:00.57), and coming back to place 8<sup>th</sup> in the 18-under C-final. **Rachel** competed in 3 events and placed 22<sup>nd</sup> overall in the prelims of the 200m backstroke (2:14.08).

- a. **Board of Directors** (reps. Rudds/Morefield) -- No recent activity. Error in minutes of April 19<sup>th</sup> BOD meeting, the 15-18 age group was added back to Summer JOs for 2018, not 2017.

## 13. Old Business and Action Items:

- a. Confirmation of Board email vote conducted May 30 - June 1, on a motion by DDST to drop the word "Invitational" from the name and format of the August High Country meet, and allow it to be open to all

eligible athletes, along with an appropriate entry limit to control session length. Votes received by the deadline: 9 in favor, 0 opposed, 0 abstentions.

**14. New Business:**

- a. Election of 2017-2018 officers. **Nominees: (Action Item)**  
Chair: Jim Morefield  
Vice Chair: Brian Holm Erik Scalise Sharon Weiss  
Secretary: Julie Hardt  
Treasurer: Jerry Rudd
- b. Bylaws state that a majority of people have to vote for a candidate for the candidate to be elected. Jim recommended that in the result none of the 3 candidates for Vice Chair receive a majority, it will go to a 2<sup>nd</sup> vote between the 2 highest tallies. Attendees agreed.
- c. Chair, Secretary, and Treasurer voted as a slate. As Chair, Jim Morefield abstained (unless he was needed to break a tie). 11 for – 0 against – 1 abstention.
- d. Vice Chair voted via paper ballots. Sharon Weiss elected with majority vote.

**15. Closed Executive Session (Elected & Appointed Officers & Athlete Representatives Only):**

- a. **Selection process for 2017-2018 Athlete Rep applications.**
- b. Given the potentially sensitive nature of individual athletes, suggested closed session.
- c. Jim would like to see representation from different clubs. There are 4 candidates from 3 different clubs (Reno, Douglas, NNA), with 3 spots available (2 reps, 1 alternate). He would like to see equal representation if possible. However, we should also be considering buy in from individual athletes and potential for drop out.
- d. Bylaws state we should have 2 reps and 1 alternate, unless Pacific Swimming requires more. Technically we could have all 4 because we should have at least 20% representation. Concern that one team may have more representation than another if we appoint all 4.
- e. Jim would like to have a closed session with Coach Erik Scalise invited since he has the team with 2 candidates (and it may come to cutting 1 of those athletes).
