### 5. Announcements & Correspondence:

- a. Congratulations to **Katie Crom (LAKE)** on being named 2016-2017 Pacific Swimming long-course female **Outstanding Swimmer** in the 13-year-old category! Katie is also a **finalist for the 2017 Pacific Swimming age-group female Race of the Year award**, for her performance in the 200m Butterfly (2:15.64) at the Western Zone Senior Championship in Clovis, CA, on August 1. - b. Congratulations to our athletes who swam as part of the winning Pacific Swimming All-star team at the 2017 **Western Zone Age Group Championships** in Roseville, CA, August 9-12. **Katie Crom (LAKE)** set new 13-14 girls WZ meet records in 200m freestyle (2:06.55), 400m IM (4:55.38), and 200m butterfly (2:19.02), and also took 1<sup>st</sup> place in 200 IM and 2<sup>nd</sup> place in 400m freestyle. **Blair Hall (LAKE)** made top-8 in 3 events including 3<sup>rd</sup> place finishes in the 13-14 100m & 200m butterfly. **Madeleine Lewis (LAKE)** finished top-8 in 2 events, including 4<sup>th</sup> in the 13-14 100m breaststroke.
- c. Congratulations to **Benedict Nagy (LAKE)** on her selection to the 2016-2017 USA Swimming Scholastic All-America Team.
- d. **Next House of Delegates Meeting Sunday, October 8<sup>th</sup>, 10:00 am, in Concord, CA.** See the Pacific Swimming web site for call-in options, and be sure your club representative information is up to date with the Pacific Swimming Registration chair.
- e. **Congratulations to Zone 4 graduates Shelby Koontz (DDST/Indiana University) and Rachel Matsumura (LAKE/Indiana University)** who competed strongly at the **2017 US Open Championships** in New York August 2-6. **Shelby** competed in 4 events, including a 10<sup>th</sup> place finish in the 100m butterfly (59.90). **Rachel** competed in 4 events and placed 15<sup>th</sup> in 200m backstroke (2:13.78).

### 6. Financial Report:

- a. Current balances and recent activity.
  - i. Balance: \$15,781.64

- i. Western Zone Age Group Champs: we had 3 athletes attend, and they were reimbursed from Zone 4 at \$250 each (1/2 of the Pacswim co-pay).
- c. Forward 2017-18 Budget proposed for approval in line with the 2016-17 Budget, with the exception of increasing the membership income budget from \$700 to \$800 due to UNR joining Zone 4 as a year round USA swim team.

**7. LSC Reports:**

- a. **Board of Directors** (reps. Rudds/Morefield) -- did not attend July 19<sup>th</sup> meeting. Time standards for short-course JO and FW meets updated and posted.
- b. **Diversity Committee** (rep. Valerie Rudd) – Valerie wasn't able to attend the most recent meeting. There is a Pacific Swimming Diversity camp coming up in November.
- c. **Athlete Committee** (reps. Sam DeRuse, Lily Bickmore, Alison Cameron, Daisy Fanter) – no recent activity.
- d. **Open Water Committee** (rep. Erik Scalise) – no recent activity.
- e. **Senior Committee** (rep. Kat Matheson) – Russell Mark from USA Swimming is doing a clinic on October 7 for free. He'll be covering some race analysis information, and it is free to coaches.
- f. **Age Group Committee** (rep. Jim Morefield) -- no recent meetings.
- g. **Governance Committee** (rep. Jim Morefield) -- no recent meetings.
- h. **Finance & Investment Committees** (rep. Jim Morefield) -- no recent meetings.
- i. **Scheduling Committee** (rep. vacant) – this committee works on scheduling Pacific Swimming hosted meets (JOs, Far Westerns, SR meets, etc.). The committee meets and decides which teams are awarded meets based on bids.
- j. **Nominations Committee** (rep. Jim Morefield) -- no recent meetings.
- k. **Safe Sport Committee** (rep. Jodi Wright) -- new committee, no meetings yet.

**8. Coaches Report:**

- a. Brendon Bray (UNR) has had a committee to see what the expansion costs would be to extend the UNR pool to be 50m and include a diving tower. It's looking like this work will be in the \$5-8 million range. Full disclosure due to the potential for a stalled process for the public pool construction. UNR President may look into being a partner in the Moana site costs. This month, the lease that Sierra Nevada swimming had on the site was up. They re-extended the lease. Brendon is looking into having the UNR new expansion be more open to the public for potential use with swim teams. Long-term vision of Lombardi is that the new student rec center will cover student life, and the Lombardi pool will be more of an athletic facility for some outside use. Brendon will keep Zone 4 updated on the developments of proposed building and expansion plans. UNR could potentially be an option of a release valve for local teams and so that UNR becomes more of a partner with the city and activities for city citizens.
