Meeting called to order by Vice Chair Chris Lam 7:30 PM. Mark Ryan not in attendance.

**MINUTES**: April minutes did not go out with meeting invite. Chris will send out tonight. We will review and approve at the June meeting.

TREASURER (Carol Cottam): deposited 20k from Fastswims/Carlene, \$1,500 in officials fines, everyone is paid except RHAC. Leo said Todd has been busy with family matters. Reimbursed Lisa, Mike, Angela and Chris for clinic expenses, food, photocopying, handouts etc. Reimbursed Dan Zhang \$38 BGC. Paid Bill of GI Graphics \$547 for officials shirts. Paid BSW 1k long course subsidy. Paid AAA/CROW/BSW about 1k each – split profits from 2023 Zone 2 Summer champs. Paid storage \$380. Lost about 2k in stock market. REMINDER: if you are hosting a long course meet, email Carol the address to send the long course subsidy check. We have about 78k in investment, 33k in checking, total 112k. ACTION ITEM: Chris Lam will send spreadsheet of Zone 2 Winter champs refunds to Carol so checks can be disbursed to teams. Treasurer report APPROVED.

**ATHLETES** Saveta Holunga not in attendance

OFFICIALS (Lisa Kaplan/Markus Daene): getting ready for fall, should be all set to go after these last rounds of meets

SAFESPORT (Dave Cottam): Kelly Schott stepping down as chair. No replacement yet. Coach Nathan (HILL) brought up issue at MONT pentathlon, unprofessional conduct by one of the officials "William" (CJ?), 5 officials standing in front of Nathan's table, blocking view, he asked them to move, official said something back (sorry, I did not get this part), official had an attitude, lashed out, very negative experience for Nathan. Nathan said there were too many officials at the meet, there should be maximum number of officials allowed on deck. Lisa Kaplan apologized on behalf of the officials, said she will touch base with Chris Lam, get details and will reach out to Phil Grant. Parents taking videos and photos behind the blocks was also a problem at the MONT meet. Nathan discussed the incident with Chris Lam who was Meet Ref at MONT. Nathan suggested we consider setting up spectator area at zone 2 meets. ELIT Coach Paschalis said the issue of spectators being allowed on deck is a problem, a big subject with coaches, and needs to be addressed. There are too many people on deck, chaos, very difficult to keep everyone safe, difficult to coach. Leo recommended a task force.

ACTION ITEM: Chris will talk to Mark Ryan about assigning someone to head a task force consisting of officials, coaches and athletes to see if closed deck meets can be done at our pools/meets.

**SANCTIONS** Angela has nothing to report, all meets have been sanctioned

<u>AGE GROUP</u> (Doug): they finalized AG and FW time standards for disabled athletes. They finalized western zone language for swimmers to qualify. *CONGRATULATIONS* to Doug who was elected to another 2 years as Pacific Swimming Age Group Chair.

**DIVERSITY:** Marie has nothing to report

**EQUIPMENT**: Leo continues to repair broken equipment, systematically replacing older equipment, making purchases, spending money. Leo will put together invoice for repair costs.
