USE OF AUDIO AND VISUAL: Photography and video recording from behind the blocks or starting areas is prohibited unless prior permission is granted by the Meet Referee. Use of any audio or visual recording devices, including but not limited to film and digital cameras, cell phones and tablets, and Google Glass is not permitted in changing areas, rest rooms or locker rooms. Violation of this recording prohibition may result in ejection from the swimming pool facility by the Meet Referee or his/her designee.

LOCATION: Sunnyvale Swim Complex @ Fremont High School, 1283 Sunnyvale-Saratoga Ave., Sunnyvale, CA 94087 ([LINK](#))

DIRECTIONS: From Interstate 280, exit N. De Anza Blvd (Sunnyvale-Saratoga Ave), travel north on Sunnyvale-Saratoga Ave until it reaches Fremont Ave. The pool is between the school's main entrance and the football field. There are two parking lots. Parking lot off of Sunnyvale-Saratoga in front of the high school will be held for meet officials and swim coaches. Participants should park in the student lot (with solar panels) on the west side of the school campus off Fremont Ave.

COURSE: Outdoor 25 yard by 50-meter pool with up to 10 lanes available for competition. An additional 9 lanes will be available for warm-up/cool down throughout the competition. The minimum water depth for the shallow end course, measured in accordance with Article 103.2.3, is 12'0" at the start end and 12'0" at the turn end. The Meet Host shall ensure the required course dimensions.

TIME: Saturday and Sunday are split into sessions "A" and "B"

Session A: 11-12* and 13 & Over Athletes. Warm-ups from 7:00-8:15 AM. Meet begins at 8:30 AM

Session B: 11-12* and 10 & Under Athletes. Session B will begin one hour after Session A finishes but not before 12:30 PM. Warm-up begins immediately after Session A finishes.

***11-12 Athletes may enter either the 'A' or 'B' session each day, but not both.**

- RULES:**
- Current USA and Pacific Swimming rules and warm-up procedures will govern the meet. A copy of these procedures will be posted at the Clerk-of-Course.
 - The local facilities guidelines, restrictions and interpretation of the local public health guidelines shall be followed at this meet.
 - All adults participating in or associated with this meet, acknowledge that they are subject to the provisions of the USA Swimming Minor Athlete Abuse Prevention Policy ("MAAPP"), and that they understand that compliance MAAPP is a condition of participation in the conduct of this competition.
 - All events are timed finals.
 - All events will swim fast to slow.
 - Athletes may compete in a MAXIMUM of 3 events per day.
 - All Athletes ages 12 and under should complete competition within four (4) hours.
 - Athletes aged 11-12 may enter only one session, either "A" or "B", but not both, per day.
 - Timers must meet USA and Pacific Swimming minimum age requirements.
 - Entries will be accepted for each session until the estimated timeline reaches its session time limit. The session time limit will be selected to assure that the final estimated timelines, including any breaks, are in accordance with the maximum session time limit (four hours).
 - The estimated timeline will be calculated using the following limits: scratch rate of seven percent (7%); heat interval of thirty seconds (30sec) for session "A"; heat interval of forty-five seconds (45sec) for session "B"; backstroke extra interval of fifteen seconds (15 sec); ten (10) competition lanes.
 - For each session the maximum session time limit is four hours (4 hours).
 - Upon closing entries, the host team and/or Meet Director will promptly review the final estimated timelines (e.g., HyTeK estimated timelines) with the Meet Referee to confirm each session is in accordance with the session time limit and with the entries NT rules. The final estimated timelines will be calculated using the above limits for scratch rate, heat interval, backstroke extra interval, and number of competition lanes.
 - No new entries will be accepted after entries (sessions) have closed.
 - Final estimated timelines must be reviewed and approved by the Meet Referee prior to the start of any session. Therefore, it is highly recommended that the final estimated timelines be prepared and reviewed with the Meet Referee at least 24 hours prior to the first session.
 - If during review of the final estimated timelines, the Meet Referee or the Meet Director determines that one or more sessions is oversubscribed, then there will be an automatic (mandatory) scratch down to bring the one or more sessions in compliance with the maximum session time limit (4 hours). Automatic (mandatory) scratches will be implemented in accordance with Pacific Swimming rules and regulations and applied uniformly to the maximum extent possible.
 - If local conditions warrant it, the Meet Referee, with the concurrence of the Meet Director, may require a mandatory scratch down. Refunds will be issued to the participating teams for any mandatory scratches.
 - To be present on deck, coaches must sign in and provide proof of current good standing USA Swimming membership.
 - **For events of distance 200-yards or more, entries with "NO TIME" will not be accepted.** A coach verified time will be accepted.
 - All Athletes entered in the 500 Free will need to provide their own lap counters
 - **All Coaches and Officials must wear their USA Swimming membership cards in a visible manner.**
 - First-aid kits and AED will be available on the pool deck. Further Medical support available via 911.

UNACCOMPANIED ATHLETES: Any USA Swimming Athlete-Member competing at the meet must be accompanied by a USA Swimming Member-Coach for the purposes of Athlete supervision during warm-up, competition and warm-down. If a Coach-Member of the Athlete's USA Swimming Club does not attend the meet to serve in said supervisory capacity, it is the responsibility of the Athlete or the Athlete's legal guardian to arrange for supervision by a USA Swimming Member-Coach. The Meet Director or Meet Referee may assist the Athlete in making arrangements for such supervision; however, it is recommended that such arrangements be made in advance of the meet by the Athlete's USA Swimming Club Member-Coach.

RACING STARTS: Athletes must be certified by a USA Swimming member-coach as being proficient in performing a racing start or must start the race in the water. It is the responsibility of the Athlete or the Athlete's legal guardian to ensure compliance with this requirement.

RESTRICTIONS:

- Smoking and the use of other tobacco products is prohibited on the pool deck, in the locker rooms, in spectator seating, on standing areas and in all areas used by Athletes, during the meet and during warm-up periods.
- Sale and use of alcoholic beverages is prohibited in all areas of the meet venue.
- No glass containers are allowed in the meet venue.
- No propane heater is permitted except for snack bar/meet operations.
- All shelters must be properly secured.
- Deck Changes are prohibited.
- Destructive devices, to include but not limited to, explosive devices and equipment, firearms (open or concealed), blades, knives, mace, stun guns and blunt objects are strictly prohibited in the swimming facility and its surrounding areas. If observed, the Meet Referee or his/her designee may ask that these devices be stored safely away from the public or removed from the facility. Noncompliance may result in the reporting to law enforcement authorities and ejection from the facility. Law enforcement officers (LEO) are exempt per applicable laws.
- Operation of a drone, or any other flying apparatus, is prohibited over the venue (pools, Athlete/Coach areas, Spectator areas and open ceiling locker rooms) any time Athletes, Coaches, Officials and/or Spectators are present.
- **Coach tents ONLY on the pool deck, no personal tents allowed. Space outside of the pool is for personal tents.**
- **Only currently registered athletes actively competing or using the warm up/warm down area, volunteers, and coaches should be on the pool deck.**
- No pets and/or animals are allowed with the exception of well-behaved service animals in accordance with ADA guidelines. The Meet Director or Meet Referee may ask any person handling a service animal to leave the premises if the service animal is barking, mis-behaving, soiling, or otherwise causing a disturbance.

ELIGIBILITY: • Athletes must be current members of USA Swimming and enter their name and registration number on the meet entry card as they are shown on their Registration Card. If this is not done, it may be difficult to match the Athlete with the registration and times database. The meet host will check all Athlete registrations against the SWIMS database

- Athletes in the "A" Division must have met at least USA Swimming Motivational "A" minimum time standard. Athletes in the "B" Division must have met at least the listed "B" minimum time standard. All entry times slower than the listed "B" time standard will be in the "C" Division.
- Entries with "NO TIME" will be ACCEPTED only for 100-yard, 50-yard, and 25-yard events. (See rules above.)
- Entry times submitted for this meet may be checked against a computer database and may be changed in accordance with Pacific Swimming Entry Time Verification Procedures.
- Athletes with a disability are welcome to attend this meet and should contact the Meet Director or Meet Referee regarding any special accommodations on entry times and seeding per Pacific Swimming policy.
- Athletes 19 years of age and over may compete in the meet for time only, no awards. Such Athletes must have met standards for the 17-18 age group.
- The Athlete's age will be the age of the Athlete on the first day of the meet.

ENTRY PRIORITY: Priority entry will be given to the following Zone 1N clubs: **ALTO, DACA, LAMV, LO, OSC, SOLO, SUNN, UCPA.** Those entering online must do so by **11:59 PM, Wednesday, October 9, 2024** to receive priority acceptance to the meet. Athletes from the Zone 1N priority clubs submitting surface mail entries must be postmarked by **Monday, October 7, 2024** to receive priority acceptance into the meet. No Athletes, other than those from the Zone 1N priority clubs may enter the meet until the priority period passes. After **October 12**, and if the estimated timeline still permits, the meet will be open to Athletes outside of the Zone 1N priority clubs.

ENTRY FEES: \$4.50 per event plus a \$10.00 participation fee per Athlete. Entries will be rejected if payment is not sent at time of request. No refunds will be made, except mandatory scratch downs.

ONLINE ENTRIES: To enter online go to <http://ome.fastswims.com> to receive an immediate entry confirmation. This method requires payment by credit card. Swim Connection, LLC charges a service fee for this service, equal to \$1 per Athlete plus 5% of the

total Entry Fees. Please note that the service fee is a separate fee from the Entry Fees. If you do not wish to pay the service fee, enter the meet using a mail entry. Entering online is a convenience, is completely voluntary, and is in no way required or expected of an Athlete by Pacific Swimming. **Online entries will be accepted through Wednesday, October 16, 2024** (pending the meet does not fill up sooner per the session four-hour time-limit, see Rules above).

MAILED OR HAND DELIVERED ENTRIES: Entries must be on the attached consolidated entry form. Forms must be filled out completely and printed clearly with Athlete’s best time. Entries must be postmarked by **midnight, Monday, October 14, 2024** or hand delivered by **6:30 p.m. Wednesday, October 16, 2024**. No late entries will be accepted. Incorrect entries will not be accepted. Requests for confirmation of receipt of entries should include a self-addressed envelope.

CHECK-IN: The meet will be deck seeded. Athletes must check-in at the Clerk-of-Course. No event shall be closed more than 30 minutes before the scheduled start of the session. Close of check-in for remaining events shall be no more than 60 minutes before the estimated time of the start of the first heat of the event. Athletes who do not check in for an event will not be seeded and will not be allowed to compete in said event.

SCRATCHES: Any Athletes not reporting for or competing in an individual timed final event that they have entered shall not be penalized.

AWARDS: Individual events will be awarded in the A, B, and C Divisions. Ribbons for 1st– 8th place are given within each division to the following age groups: 6/un, 7-8, 9-10 and 11-12. Athletes 13 years of age and older will not receive ribbons. “A” medals will be awarded to Athletes achieving NEW Motivational Time Standard “A” times in each event, regardless of place achieved in the event. All awards must be picked up at the meet by club coach or team representative. Awards will not be mailed.

ADMISSION: Free. A program file (PDF) will be emailed to all club coaches prior to the meet.

SNACK BAR & HOSPITALITY: A limited snack bar will be available throughout the competition. Coaches and working Officials will be provided a light breakfast and lunch. Hospitality will serve refreshments to timers and volunteers.

MISCELLANEOUS: • No overnight parking is allowed. Facilities will not be provided after meet hours.

- Disobeying parking signs may result in a citation and a fine.
- All participating clubs are expected to provide lane timers based on the number of athletes registered to swim each day and session. Coaches/clubs will be notified of club timing lane assignments the Monday prior to the meet.

MINIMUM OFFICIALS: Clubs must follow Z1 North rules for providing officials. Each club must provide officials for each session according to the number of athletes entered in that session, following the table below.
